Institute of Horticulture (Hong Kong)

The Institute of Horticulture (Hong Kong) was established on 20.6.1988 as Society of Horticulture, Hong Kong and renamed in August 2002 as Institute of Horticulture (Hong Kong) to reflect the expansion and increased commitments in promoting horticulture.

Objectives of the Institute

- To promote the study of horticulture;
- To raise the standards of practices in horticulture;
- To encourage the interest in horticulture; and
- To organise, co-ordinate and undertake educational activities pursuant to the above objects.

Membership

Membership shall include 7 categories:-

- Fellow:** Members in this category shall be persons who have distinguished ability and contributions in horticulture and have been recommended by the Councillors of the Institute.
- Full Member:** This category of membership is open to persons who have satisfactorily completed a 1-year full time certificate or diploma course in horticulture in a recognised college or institute.
- Associate Member:** This category is open to persons who are qualified in a related field of horticulture and whose main professional occupation is directly involved in horticulture or a branch of science or art having a direct bearing in horticulture.
- Honorary Member:** Members in this category shall be persons who have been recommended by the Councillors of the Institute as such in recognition of their contributions in horticulture or in a related field.
- Corporate Member:** Associations, institutions, firms, companies or other corporate bodies shall apply for admission to this category. Upon being admitted, a Corporate Member may submit to the Councillors the name of one representative who shall represent the Corporate Member.
- Ordinary Member:** This category is open to persons who have a genuine interest in horticulture.
- Student Member:** This category is open to persons who are undertaking a course of study organised or recognised by the Institute leading to Full Membership.

Every candidate for all categories of membership must be over 17 years old, and be proposed by a Full Member personally acquainted with him and seconded by one other Full Member.

In applying for membership, a candidate should forward a completed application form to the Secretary who would then submit to the Council of the Institute for approval. The Executive Council has the right to reject an application without giving any reason.

A candidate shall become a member when his application is approved by the Councillors and the prescribed fees are paid.

Rights of the Members:

- Only the Fellow and Full Members shall have the right to elect, stand for elections, proposed, vote and recall.
- All members shall have the right to enjoy the benefits as arranged by the Institute.

Obligations of the Members:

- To abide by the Constitution of the Institute and the resolutions passed by the General and Extra ordinary Meetings.
- To pay the annual subscriptions and other prescribed fees the amount of which shall be decided by the Executive Council of the Institute from time to time.

香港園藝學會於在八八年六月二十日正式成立。為了更具體反映中文名稱的意義及會務政策方向，學會英文名稱”Society of Horticulture (Hong Kong) 由二零零二年八月改為”Institute of Horticulture (Hong Kong)，而中文名稱不變。

本會宗旨如下：

- 項(一) 促進園藝研究工作。
- 項(二) 提高園藝技術水平。
- 項(三) 推廣園藝興趣。
- 項(四) 組織統籌及進行與上述有關之教育性活動。

會員：

本會共有下列七種會員：

- 項(一) 院士：凡在園藝工作或其有關行業曾作極大貢獻者，均可由本會之理事會推薦為院士。
- 項(二) 基本會員：凡曾經在認可學院修讀一年制園藝課程者均可申請。
- 項(三) 同業會員：凡就業於與園藝有關之行業，而同時持有該行業之專業資格者，均可申請。
- 項(四) 名譽會員：凡在園藝工作或其有關行業作出貢獻者，均可由本會之理事會推薦為名譽會員。
- 項(五) 團體會員：其他團體商業機構，註冊公司和學術性機構均可申請。每一團體會員可委派一名代表，參與本會之活動，但需將該代表之名字向理事會存案。
- 項(六) 普通會員：任何人仕對園藝有興趣者，均可申請。
- 項(七) 學生會員：凡正在修讀基本會員所認可之課程者，均可申請。

任何人仕有興趣加入本會者，須得到一名基本會員提名，另加入一名基本會員和議及年滿十七歲，方可申請為會員。

申請入會手續：申請人須將申請格填妥，交回本會秘書，轉呈理事會考慮及批准，無論接受與否，理事會無須公報原因。

入會申請經理事會接納後，申請人必須繳付全部規定的費用，才正式成為本會會員。

權利：

- 項(一) 祇有院士及基本會員才有選舉、被選、提案表決及罷免權。
- 項(二) 所有會員均有權享用本會一切活動及福利。

義務：

會員的義務如下：

- 項(一) 遵守本會會章及服從由會員大會及特別會員大會通過的決議。
- 項(二) 按時繳交年費及其他由理事會訂定的各項費用。
